A **DoTDirect** online account is a free personalised account where you are able to manage all information relating to your personal **vehicle licence** and **driver's licence**.

This is a great online tool which allows you to view all your licences, pay bills, transfers vehicles, obtain permits and much more.

Registration is easy all you need is your driver licence then visit the following link http://www.transport.wa.gov.au/dotdirect/dotdirect.asp and request a code, which will be mailed to you within a few days.

At the ordinary council meeting on Thursday 22 October 2015, Scott Uppill and Carol Crane were both re-elected as President and Deputy President respectively for a term of 2 years each.

New administration "vehicle"

The Shire has purchased a bicycle for all employees to use if they wish to do the mail run or any other errands around town.

This is to offer a healthy and environmentally friendly alternative to using the car.

Restricted burning period, firebreaks & harvest and vehicle movement bans

Restricted burning period: 15 October to 31 October 2015 — Burning permit required

Prohibited burning period: 1 November 2015—14 February 2016—NO burning permitted

Restricted burning period: 15 February 2016—15 March 2016 — Burning permit required

Burning permits can be obtained from Haydn Dixon (Ph: 04 290 452 05), Shayne Mackin (Ph:04 283 810 27) or Tim York (Ph:04 277 371 13).

All **firebreaks** must be prepared on or before the **1 November 2015** (or within 14 days of you becoming the owner or occupier of a property, should this be after that date) and maintained clear of inflammable material up to and including the 1 day of April 2016.

Harvest and vehicle movement bans will be applied by the Chief Bush Fire Control Officer when weather conditions indicate it is necessary. A text message to registered mobile phones, announcing bans will be sent out. If you wish to receive those SMS, please register your mobile number and name with the Shire office by phone or email to shire@tammin.wa.gov.au.

A message via UHF two-way radio network will be used to broadcast bans. Information as to whether a ban is in place will also be available from a recorded message by calling 9637 0309.

Dog and cat registrations are due on 1 November 2015

Letters to cat / dog owners will be sent out as a reminder. If you are new in town or have a new pet please come to the Shire office to license it.

Is Your Dog Microchipped?

The *Dog Act 1976* provides that on and after 1 November 2015, the owner of a dog that has reached three months of age must ensure that the dog is microchipped.
