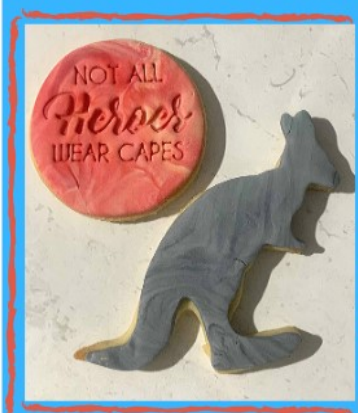

Terms & Conditions Agreement

Participation in the FUSE Festival is subject to your acceptance of the following terms and conditions. Please read these carefully.

1. **Applications:** The Shire of Tammin reserves the right to decline any application. Preference may be given in order of application and/or nature of product when allocating sites.
2. **Products:** It is important that you specify the nature of your stall and the types of product to be sold. Stallholders contravening this requirement or failing to accurately describe their products may have their trading terminated.
3. **Licences and permits:** It is required that you hold all required licences and permits to sell your products and obey all laws and regulations involving your products.
4. **Environment and waste:** The Shire of Tammin does their best to ensure that the festival grounds are left free of waste at the conclusion of the FUSE Festival. Please try to reduce waste and use recycled and/or recyclable packaging and materials and remove all waste at the end of the day.
5. **Set up time:** The FUSE Festival trading times are from 11:00am to 3:30pm. Shire of Tammin staff will be on location from 9:00am. Stall holders are asked to be on site by 10:00am and be ready to operate by 10:45am. Stallholders are asked to keep their stall open until 3:30pm.
6. **Site:** Site size is a maximum of 1.8m x1.8m. Exceptions are possible prior to discussion. Please bring your own tables. All trestle/display tables must be covered with floor length tablecloths. All displays, tables or otherwise must be contained within the site space. Please note that all sites are unpowered. Exceptions are possible prior to discussion. Stall holders will be allocated a space in the marquee on the oval but depending on demand, some stalls will need to provide their own shelters, notification will be given in due time.
7. **Health and Safety:** Stallholders are responsible for the safety of the public within the allocated stall area and for the safety of products sold. Stallholders must ensure that all shelters, cabanas, umbrellas, tables, display boards etc. are adequately secured and comply with all safety regulations as requested by the Shire of Tammin festival officials. Soft objects (sandbags or plastic water containers) must be used as hold-downs. Keep walkways clear and report any hazards to the Safety officer at the information station. All stallholders vending any foodstuffs/drinks (whether prepared on site or not) must comply with the 2008 Food Act and the Australian and New Zealand food standards code. This is a Smoke Free event and smoking by stall holders is discouraged by The Shire of Tammin.
8. **Public Liability Insurance:** Stallholders who hold adequate public liability insurance are asked to forward a copy of their Public Liability Insurance (PLI) Certificate of Currency to the Shire when registering their stall. Stallholder without Public Liability Insurance will be covered by a policy taken out by the Shire of Tammin for this event.

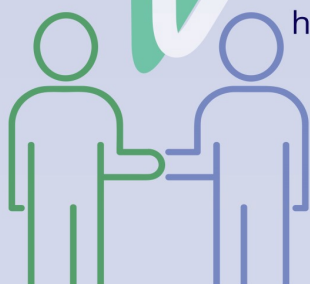

Works & Services - January 2019

Works and Services Crew have been busy since the New-Year with preparation and stabilisation works before sealing program due on Tuesday 4th February.

The road shoulders have been widened on sections of Tammin Wyalkatchem Rd and Tammin South Rd in preparation for the works . It is anticipated the work to be completed early February.

The Shire of Tammin would like to advise that a section of Tammin Wyalkatchem Rd and Tammin South Rd are under traffic control for the next 2 weeks, please be aware that the traffic conditions will be changed during the works. We also advise to drive carefully on new section of roads.

As you may have noticed, the corellas seemed to have moved on, away from Tammin and have migrated in a Westerly direction. We will keep monitoring the area should they come back within the Shire of Tammin, appropriate action will take place.

The cricket pitch is finished and final preparation was made before the match over the last week end. The pitch looks great, thanks for the effort of all who did contribute to it.

The new pedestrian cross over works at the train station is under work and should be finished by 5th February. This will ensure a safe passage for all pedestrian.

Works and services are still looking for some existing or potential gravel pits, around the month of February 2020, I will be in contact with land owners to identify and excavate some test pits in area where gravel could be sourced for the maintenance of the road network. This gravel would be used within a radius of 10km of pit to improve conditions of existing unsealed roads.




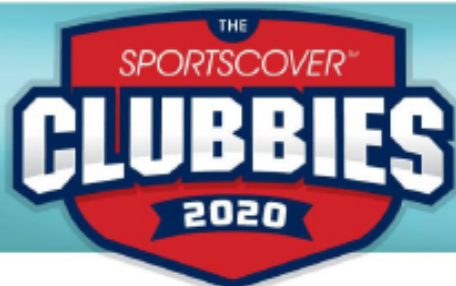
