Southwest Yilgarn Exploration Project

Dear Landowner,

Activity Notice—Regional Airborne Survey Southwest Yilgarn Exploration Project

Anglo American has been granted permits to explore an area of around 10,000 square kilometres in the Wheatbelt region of Western Australia, about 230 kilometres east of Perth.

The Southwest Yilgarn Exploration Project is early stage exploration work and will include low impact data collection activities over a 12–18 month period. The project is exploring for base and precious metals including battery metals such as copper and nickel.

The commencement of the project involves an airborne electromagnetic (AEM) survey for approximately a five month period starting in late 2021. The flight path is from the Shire of Cunderdin in the north to Dumbleyung in the south and requires **a single pass only** by the helicopter along spaced flight lines 400 metres apart.

As the project advances, further information specific to your area is scheduled to be published in your local shire newsletters.

AEM survey method and what you may see

AEM surveys are widely used by government and industry for mapping rock types and minerals underground. The surveys are a non-invasive technology and are not harmful to humans or livestock.

A helicopter fitted with electromagnetic instruments will map variations in the electrical conductivity of the ground to a depth of several hundred metres without any disturbance to the ground. All flight plans are approved and managed through CASA procedures. The survey involves a helicopter flying during the day. A transmitter and receiver loop are towed by the helicopter at a height of 35 metres above the ground (refer to Figure 1).

The survey crew will minimise potential impacts to livestock by increasing flying height where concentrations are sighted, for example yards and sheds.

Project timeline

The first 12-18 months of work involves baseline data acquisition for the purpose of geological validation and prospect definition. If the aerial survey identifies an area that requires further assessment the project team would be in touch with the relevant landholders to discuss a land access and compensation agreement to undertake further activities. These activities could include low impact drilling (refer Figure 2 & 3) for core samples.

Important information about your water supply



If your property is tenanted, please pass this notification on to the occupier.

Low water pressure – Tammin town 7pm Wednesday 10 November – 7pm Thursday 11 November 2021

Water Corporation is upgrading a 1.4km length of the Goldfields Pipeline that supplies water to customers between Perth and Kalgoorlie. The section, located between Tammin and Kellerberrin, is aged and needs replacing to ensure reliability of water supply to nearby customers.

On two occasions in recent months, we have temporarily disconnected the town of Tammin from the Goldfields Pipeline and supplied customers via portable tanker for a 24 hour period to allow us to complete critical work. Most work has been going well, however we are required to temporarily disconnect the town of Tammin from the Goldfields Pipeline a third time. We do hope this will be the final disconnection required to complete this work.

Tammin town properties will be supplied potable water via a portable tank, which will be at lower pressure, during this time, before we restore the main supply and reconnect the town.

When: 7pm Wednesday 10 November - 7pm Thursday 11 November 2021

During this time, toilets and other water using appliances may take longer to fill, or you may notice water from your taps being of lower pressure than usual.

Water Corporation appreciates this essential work will cause some inconvenience to some customers in Tammin and we thank you in advance for your cooperation.

Discoloured Water

This work may result in the water having a discoloured appearance. If this occurs, the water is still safe to drink however:

- 1. Run the outside garden tap at the front of your property for a few minutes, until the water clears.
- 2. Repeat the step above for an outside tap at rear of your property.
- 3. Call us on 13 13 75 if the water does not clear.
- 4. Do not use washing machines, dishwashers or other water-using appliances until the water is clear.

have special circumstances we need to be aware of before this essential work starts are experiencing issues with your water supply service.

CALL 000 TO REPORT A FIRE!

BUSHFIRES ACT

FUEL REDUCTION AND FIRE-BREAK REQUIREMENTS

Pursuant to the powers contained in Section 33 of the Bush Fires Act 1954, you are hereby

required on or before the 1st day of November 2021 to construct fire breaks and/or clear your property of flammable material in accordance with the following, and thereafter to maintain fire breaks up to and including the 1st day of April 2022.

Townsite:

Land Area less than 2048m2

All hazardous material is to be removed from the whole of the land except living trees, shrubs and plants. The remaining vegetation is to be maintained to a height of no greater than 7.5cm.

Townsite:

Land Area greater than 2048m2

All land over $2048m^2$ is to comply with the requirements of rural land.

This is to be maintained for the duration of the restricted and prohibited burning periods.

Tammin Rural Land

All land is required to have a bare mineral earth fire break not less than 3 meters in width immediately inside all external boundaries of said land.

All land surrounding erected buildings is required to be cleared of all flammable material by way of burning, slashing or mowing, and maintained to a height not greater than 75mm.
