Fire Breaks

Reminder letters have been sent to townsite properties assessed as being a likely fire risk if action is not taken to comply with the Shire of Tammin's Firebreak Order.

A letter has also been sent to all rural property owners reminding them of their firebreak obligations.

The Shire of Tammin's Firebreak Order requires 3m firebreaks around the property boundary and around all buildings on the property by 1 November and to be maintained through to 1 April. Consideration is being given to the issue of Infringements for those property owners who have failed to carry out these works. If you have an opinion on this issue, you are urged to contact your local Councillor or Fire Control Officer.
