# 11.3 2011-12 Annual Budget - Members Allowances (FIN- 04)

#### **DECLARATION OF INTEREST**

Nil. Section 5.63(c) exempts members from being required to declare an interest in relation to the setting of a fee, reimbursement or allowance of the type that is the subject of this item.

#### **PREVIOUS REFERENCE**

#### **BACKGROUND**

Each year as part of the budget process Council is required to set Members allowances and sitting fees. The Local Government Act 1995 and the Local Government (Administration) Regulations prescribe various minimum and maximum amounts that are payable as well as various allowances and limits that may be paid. For the 2010/11 Annual Budget Council set the following amounts for allowances, fees and reimbursements:

President's Allowance \$1,000 per annum

Attendance fees — President \$120 per Council meeting

- Councillors \$ 60 per Council meeting

Travelling to & from Council Meetings per kilometre rate based on Award

#### COMMENT

These items have not changed for the past three years apart from the kilometre rate which increases in line with the Award. These limits have not always been the same, in fact in earlier years the Council has set higher allowances. For example in 2001/02 the President's allowance was \$1,500 and the sitting fees were \$150 per meeting for the President and \$95 per meeting for Councillors. In 2006 the President's Allowance was set at \$2,000 and \$170 and \$90 respectively.

The legislation provides for allowances to be set to reduce the burden of proof on Councillors for some expenses. These include Telecommunications (\$2,400 max); Information Technology (\$1,000 max) and Travelling (per kilometre on Award Rates).

If these allowances are not set Councillors have an as of right ability to be reimbursed for the actual cost of one telephone line and one fax line; actual travelling costs incurred and actual child care costs incurred up to a maximum of \$20 per hour.

Given the continuing decline in the value of a dollar due to inflation, the increased burdens on elected members due to the economic and climatic situations, the likely increased burden on councillors due to structural reform and the likelihood that there may be up to four new councillors in October it is timely that Council gives consideration to increasing the payments made to members.

The "Regional Business Plan – Current State" for SEARTG report reveals the following:

As can be seen from the above table the payments that Tammin elected members receive are substantially below that of the other SEAVROC councils and that is likely to be replicated across other councils. Councillors would be aware that for many people the personal cost of attending a Council meeting far outweighs the meagre amount that is paid and it is not unreasonable to consider increasing the amount paid.

In addition to attendance fees both the President and Deputy President are required to sacrifice much time in representing the Council on many occasions at meetings such as Great Eastern Zone, SEARTG and many other special local government events and meetings that seem to occur on an ever increasing basis. Apart from the loss of personal time that takes people away from their businesses there is the additional cost associated with increased dry cleaning and clothing costs. It is therefore reasonable to consider increasing the President's allowance and to consider introducing an allowance for the Deputy President.

#### STATUTORY ENVIRONMENT

The Local Government Act 1995 states:

## 5.98. Fees etc. for council members

- (1) A council member who attends a council or committee meeting is entitled to be paid
  - (a) the prescribed minimum fee for attending a council or committee meeting; or
  - (b) where the local government has set a fee within the prescribed range for council or committee meeting attendance fees, that fee.
- (2A) A council member who attends a meeting of a prescribed type at the request of the council is entitled to be paid
  - (a) the prescribed minimum fee for attending a meeting of that type; or
  - (b) where the local government has set a fee within the prescribed range for meetings of that type, that fee.
- (2) A council member who incurs an expense of a kind prescribed as being an expense
  - (a) to be reimbursed by all local governments; or
- (b) which may be approved by any local government for reimbursement by the local government and which has been approved by the local government for reimbursement,

is entitled to be reimbursed for the expense in accordance with subsection (3).

- (3) A council member to whom subsection (2) applies is to be reimbursed for the expense —
- (a) where the minimum extent of reimbursement for the expense has been prescribed, to that extent; or
- (b) where the local government has set the extent to which the expense can be reimbursed and that extent is within the prescribed range (if any) of reimbursement, to that extent.

- (4) If an expense is of a kind that may be approved by a local government for reimbursement, then the local government may approve reimbursement of the expense either generally or in a particular case but nothing in this subsection limits the application of subsection (3) where the local government has approved reimbursement of the expense in a particular case.
  - (5) The mayor or president of a local government is entitled, in addition to any entitlement that he or she has under subsection (1) or (2), to be paid
    - (a) the prescribed minimum annual local government allowance for mayors or presidents; or
- (b) where the local government has set an annual local government allowance within the prescribed range for annual local government allowances for mayors or presidents, that allowance.
  - (6) A local government cannot
    - (a) make any payment to; or
    - (b) reimburse an expense of,
      - a person who is a council member or a mayor or president in that person's capacity as council member, mayor or president unless the payment or reimbursement is in accordance with this Division.
  - (7) A reference in this section to a "committee meeting" is a reference to a meeting of a committee comprising
    - (a) council members only; or
    - (b) council members and employees.

# 5.98A. Allowance for deputy mayor or deputy president

- (1) A local government may decide\* to pay the deputy mayor or deputy president of the local government an allowance of up to the prescribed percentage of the annual local government allowance to which the mayor or president is entitled under section 5.98(5).
- \* Absolute majority required.
- (2) An allowance under subsection (1) is to be paid in addition to any amount to which the deputy mayor or deputy president is entitled under section 5.98.

## 5.99. Annual fee for council members in lieu of fees for attending meetings

A local government may decide\* that instead of paying council members a fee referred to in section 5.98(1), it will instead pay all council members who attend council or committee meetings —

- (a) the prescribed minimum annual fee; or
- (b) where the local government has set a fee within the prescribed range for annual fees, that fee.

## 5.99A. Allowances for council members in lieu of reimbursement of expenses

A local government may decide\* that instead of reimbursing council members under section 5.98(2) for all of a particular type of expense it will instead pay all council members —

(a) the prescribed minimum annual allowance for that type of expense; or

<sup>\*</sup> Absolute majority required.

(b) where the local government has set an allowance within the prescribed range for annual allowances for that type of expense, an allowance of that amount.

and only reimburse the member for expenses of that type in excess of the amount of the allowance.

## 5.100. Payments for certain committee members

- (1) A person who is a committee member but who is not a council member or an employee is not to be paid a fee for attending any committee meeting.
- (2) Where —
- (a) a local government decides that any person who is a committee member but who is not a council member or an employee is to be reimbursed by the local government for an expense incurred by the person in relation to a matter affecting the local government; and
- (b) a maximum amount for reimbursement of expenses has been prescribed for the purposes of section 5.98(3)(b),

the local government must ensure that the amount reimbursed to that person does not exceed that maximum.

## 5.101. Payments for employee committee members

- (1) A committee member who is an employee is not to be paid a fee for attending any committee meeting.
- (2) Nothing in this section prevents a local government from reimbursing an employee for an expense incurred by the employee in relation to a matter affecting the local government.

# 5.101A. Regulations about payment of expenses

Regulations may be made about the method of payment of an expense for which a person can be reimbursed.

# 5.102. Expense may be funded before actually incurred

Nothing in this Division prevents a local government from making a cash advance to a person in respect of an expense for which the person can be reimbursed.

The Local Government (Administration) Regulations 1996 state:

# 30. Meeting attendance fees — s. 5.98(1)

- (1) For the purposes of section 5.98(1), subject to subregulation (3)
  - (a) the minimum fee for a council member other than
    - (i) the mayor or president; or
    - (ii) in the case of a regional local government, the chairman, attending a council meeting is \$60 for each meeting; and
  - (b) the maximum fee for a council member other than
    - (i) the mayor or president; or
    - (ii) in the case of a regional local government, the chairman,

<sup>\*</sup> Absolute majority required.

attending a council meeting is \$140 for each meeting.

- (2) For the purposes of section 5.98(1), subject to subregulation (3) or (5), as the case requires
  - (a) the minimum fee for a council member attending a meeting of a committee of which he or she is also a member is \$30 for each meeting; and
- (b) the maximum fee for a council member attending a meeting of a committee of which he or she is also a member is \$70 for each meeting.
  - (3) The total of fees paid to a council member other than
    - (a) the mayor or president; or
    - (b) in the case of a regional local government, the chairman,

for attending meetings (whether of the council or of any committee) in each year is not to exceed \$7 000.

- (4) For the purposes of section 5.98(1), subject to subregulation (5)
  - (a) the minimum fee
    - (i) for the mayor or president; or
    - (ii) in the case of a regional local government, for the chairman, attending a council meeting is \$120 for each meeting; and
  - (b) the maximum fee
    - (i) for the mayor or president; or
    - (ii) in the case of a regional local government, for the chairman, attending a council meeting is \$280 for each meeting.
- (5) The total of fees paid
  - (a) to the mayor or president; or
  - (b) in the case of a regional local government, to the chairman,

for attending meetings (whether of the council or of any committee) in each year is not to exceed \$14 000.

# 31. Expenses that are to be reimbursed — s. 5.98(2)(a) and (3)

- (1) For the purposes of section 5.98(2)(a), the kinds of expenses that are to be reimbursed by all local governments are
  - (a) rental charges incurred by a council member in relation to one telephone and one facsimile machine; and
  - (b) child care and travel costs incurred by a council member because of the member's attendance at a council meeting or a meeting of a committee of which he or she is also a member.
- (2) The extent to which an expense referred to in subregulation (1)(a) can be reimbursed is the actual amount.
- (3) The extent to which child care costs referred to in subregulation (1)(b) can be reimbursed is the actual cost per hour or \$20.00 per hour, whichever is the lesser amount.
- (4) The extent to which travel costs referred to in subregulation (1)(b) can be reimbursed
  - (a) if the person lives or works in the local government district or an adjoining local government district, is the actual cost for the person to travel from the person's place of residence or work to the meeting and back; or

- (b) if the person does not live or work in the local government district or an adjoining local government district, is the actual cost, in relation to a journey from the person's place of residence or work and back —
- (i) for the person to travel from the person's place of residence or work to the meeting and back; or
  - (ii) if the distance travelled referred to in subparagraph (i) is more than 100 km, for the person to travel from the outer boundary of an adjoining local government district to the meeting and back to that boundary.
  - (5) For the purposes of subregulations (2) to (4), actual amounts and actual costs are to be verified by sufficient information.

# 32. Expenses that may be approved for reimbursement —s. 5.98(2)(b) and (3)

- (1) For the purposes of section 5.98(2)(b), the kinds of expenses that may be approved by any local government for reimbursement by the local government are—
- (a) an expense incurred by a council member in performing a function under the express authority of the local government;
- (b) an expense incurred by a council member to whom paragraph (a) applies by reason of the council member being accompanied by not more than one other person while performing the function if, having regard to the nature of the function, the local government considers that it is appropriate for the council member to be accompanied by that other person; and
- (c) an expense incurred by a council member in performing a function in his or her capacity as a council member.
  - (2) The extent to which an expense referred to in subregulation (1) can be reimbursed is the actual amount, verified by sufficient information.

## 33. Annual local government allowance for mayors or presidents — s. 5.98(5)

- (1) For the purposes of section 5.98(5) —
- (a) the minimum annual local government allowance for a mayor or president is \$600; and
  - (b) the maximum annual local government allowance for a mayor or president is
    - (i) \$12 000; or
    - (ii) 0.002 of the local government's operating revenue,

whichever is the greater amount, but in any case no more than \$60 000.

(2) In this regulation —

**operating revenue** has the meaning that it has in the Local Government (Financial Management) Regulations 1996.

## 33A. Annual local government allowance for deputies — s. 5.98A

For the purposes of section 5.98A(1) the prescribed percentage is 25%.

#### 34. Annual attendance fees — s. 5.99

- (1) For the purposes of section 5.99
  - (a) the minimum annual fee for a council member other than
    - (i) the mayor or president; or
    - (ii) in the case of a regional local government, the chairman, attending meetings (whether of the council or of any committee) is \$2 400; and
  - (b) the maximum annual fee for a council member other than
    - (i) the mayor or president; or
    - (ii) in the case of a regional local government, the chairman, attending meetings (whether of the council or of any committee) is \$7 000.
- (2) For the purposes of section 5.99
  - (a) the minimum annual fee
    - (i) for the mayor or president; or
    - (ii) in the case of a regional local government, for the chairman, attending meetings (whether of the council or of any committee) is \$6 000; and
  - (b) the maximum annual fee
    - (i) for the mayor or president; or
    - (ii) in the case of a regional local government, for the chairman, attending meetings (whether of the council or of any committee) is \$14 000.

# 34A. Allowances in lieu of reimbursement of telecommunications expenses — s. 5.99A

For the purposes of section 5.99A(b), the maximum total annual allowance for telephone and facsimile machine rental charges referred to in regulation 31(1)(a) and any other telecommunications expenses that might otherwise have been approved for reimbursement under regulation 32 is \$2 400.

# 34AA. Allowances in lieu of reimbursement of information technology expenses — s. 5.99A

For the purposes of section 5.99A(b), the maximum total annual allowance for information technology expenses that have been approved for reimbursement under regulation 32 is \$1 000.

# 34AB. Allowances in lieu of reimbursement of travelling and accommodation expenses — s. 5.99A

## **BACKGROUND**

Local Governments in Australia have been receiving direct funding from the Federal Government through the "Roads to Recovery Program" to help address road infrastructure renewal and expansion shortfalls. The current program which is the third in the series is due to end in 2014 however the identified road infrastructure shortfall has not been addressed and further commitment is required. Current funding is based on road length and for Tammin this equates to \$141,151 per annum.

The Australian Local Government Association requests the support of all local governments for a lobbying process to ensure the continuation of this highly beneficial funding program beyond 2013/14.

## **COMMENT**

Road funding at this level is vital to assist in dealing with the road and transport tasks at the current levels. Loss of income of this scale would severely impact on the Council's budget and works programming as the amount received equates to approximately 21% of rate income.

## **BACKGROUND**

It has been proposed that the Federal Government conducts a referendum in 2013 seeking to alter the Constitution to grant formal recognition of Local Government in the Australian Constitution. Both the Australian Local Government Association and the Western Australian Local Government Association have requested Council's formal support for recognition of Local Government in the Constitution. Local Government has lobbied for over 30 years to achieve recognition in the Australian Constitution as opposed to the current status of being creatures of the States.

#### COMMENT

Whilst previous Referenda on this issue have been defeated, the maturity of Local Government as a tier of Government, direct funding opportunities, acceptance and recognition of change and the current political climate would indicate a far higher chance of success.

Local Government will change dramatically into the future e.g. forced or voluntary amalgamations, infrastructure funding decisions, transport, telecommunications, health care, etc and constitutional recognition will at least place Local Government in the arena of Government and decision making rather than being simply a service provider.

At the recent Local Government Week Convention held in Perth, Professor George Williams, a Constitutional law expert from the University of New South Wales, pointed out that without Constitutional Recognition direct funding by the Federal Government to Local Government could be put at risk by a legal challenge. This would directly threaten vital programs such as Roads to Recovery and the recent Regional and Local Infrastructure Program.

The risk of such a legal challenge grows all the time as witnessed by a current case where a Brisbane man is challenging the Federal Government's right to send asylum seekers, arriving illegally by boat, to Malaysia. All it would take is for someone with a big enough grudge against Local Government that also has the resources and ability to mount a challenge and we could be threatened.

## **BACKGROUND**

The Tammin LCDC has been inactive for many years. It was an incorporated body that was one of many set up around the State over 20 years ago to be responsible for land care issues, principally salinity, in rural areas and was the conduit at the time for a lot of Federal Government and other funding. Over the years the funding has dried up as has the enthusiasm of the community to be actively involved in the activities of the LCDC's. A large number of them including Tammin's have become inactive and have not conformed with the requirements of their incorporation. The Department of Agriculture has been moving to tidy the situation up and has been in the process of winding up non-active LCDC's.

In Tammin Tony York has been acting as the President and Jill Rogers the Treasurer. The Tammin LCDC was holding funds of \$10,824.11. John Borger from the Department of Agriculture and Food was in contact with Tony and together they approached me to see whether we would have any problems in holding the funds in trust. The funds are to be utilised by a CSIRO researcher who is developing a group of salt bushes that will be suitable to this area that will give better nutritional value than existing species being used.

Tony has since arranged to transfer the funds to the Department of Agriculture. They now seek to transfer the funds to our control and have requested that I forward them a tax invoice for that purpose. They also require our formal support for the winding up of the LCDC.

#### COMMENT

The holding of the funds will present no problems. They can simply be transferred into our trust account and when they are required by the researcher we can remit them.

The formal winding up of the LCDC appears to be a logical move. It appears that its purpose has passed. It has not operated for many years and has not met the requirements of Incorporation. There are other groups within the Shire that can deal with the issues that an LCDC may have dealt with in the past and if people are not willing to meet and participate they can't be forced.
