




Message from Office..

This role specialises in Emergency Management, the development of emergency plans, assisting with bush fire control, management of the Local Emergency Management Committee and generally acting as liaison between the Department of Fire and Emergency Services (DFES) and the Shire of Tammin. I have been doing this role for over four years for the Shire's of Cunderdin and Quairading expanding to work in Tammin and Kellerberrin in March of this year.

Prior to this position I worked as a ranger in the Shire of York servicing all of the above Shires as well as the Shire of Beverley.

Even further back I started my working life as a Bricklayer in NSW moving to Perth in 2006. I have worked in QLD and VIC as well as WA and NSW.

INVESTMENT IN EMERGENCY SERVICES

The State Government will invest an additional \$128.5 million over the next four years to strengthen community safety and provide critical emergency services. This is in recognition of community feedback following a series of catastrophic bushfires as well as climate change impacts and the State's increasing population.

The 2018-19 Emergency Services Levy (ESL) will provide facilities, equipment and resources, protective clothing, uniforms, vehicles and training for Western Australia's fire and emergency services personnel, both career and volunteer.

The ESL also supports specialist activities such as fire investigations, building inspections, emergency planning and community safety programs.

Every cent raised from the ESL will go back into emergency services throughout the State to improve the safety of our personnel and the community.

This year's ESL, which will modestly increase up to 10 per cent, will also fund a new Rural Fire Division dedicated to improving bushfire management.

ESL CHARGES 2018-19

ESL charges reflect the type of emergency services available to a property. The ESL category classification of your property is shown on the rates notice. In 2018-19 ESL charges will raise \$391 million across the State.

Properties classified ESL category 1 to 4 are charged based on the gross rental value (GRV) determined by the Valuer General and the declared ESL rate for that category. Charges are subject to declared minimum and maximum thresholds based on property use. Properties classified ESL category 5 attract a fixed annual charge.

ESL CONCESSIONS

If you are a pensioner or senior who qualifies for a rebate on your council rates, you will receive the same percentage of rebate on your ESL charge. These rebates are generally combined and printed as one amount on the council's rates notice for your property.

LATE PAYMENT INTEREST

A late payment penalty of 11 per cent interest per annum is charged where the ESL payment is received after the due date, detailed on your rates notice.

Important things to know before your skin appointment.



The mobile skin clinic will be held at Tammin Lesser Hall. (3 Donnan St, Tammin)

Please note that you will need to arrive 10 minutes before your chosen appointment time. This allows time for registration and a brief medical history to be completed.

Please remember to bring your Medicare/DVA card in order for your appointment to be Bulk Billed. Without the card, you will be charged for the appointment.

If you want a full body check-up, you will be required to undress to your underwear – we will provide a towel to drape over yourself. If you only want certain parts to be checked, make sure our Medical Practitioner is able to view it.
