Shire of Tammin 2018 Fire Break Order



Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, you are hereby required **on or before the 1st day of November 2018** to construct fire breaks and/or clear your property of flammable material in accordance with the following, and thereafter to maintain fire breaks **up to and including the 1st day of April 2019**.

Tammin Townsite

Land Area less than 2048m²

All hazardous material is to be removed from the whole of the land except living trees, shrubs and plants. The remaining vegetation is to be maintained to a height of no greater than 7.5cm.

Land Area greater than 2048m²

All land over 2048m² is to comply with the requirements of rural land. This is to be maintained for the duration of the restricted and prohibited burning periods.

Tammin Rural Land

All land is required to have a bare mineral earth fire break not less than 3 meters in width immediately inside all external boundaries of said land.

All land surrounding erected buildings is required to be cleared of all flammable material by way of burning, slashing or mowing, and maintained to a height not greater than 75mm.

Failure to comply with this Fire Break Order may result in an infringement notice being issued without further notice.



The Tammin Refuse Site is open every **Thursday** and **Saturday** from **9am - 1pm**.

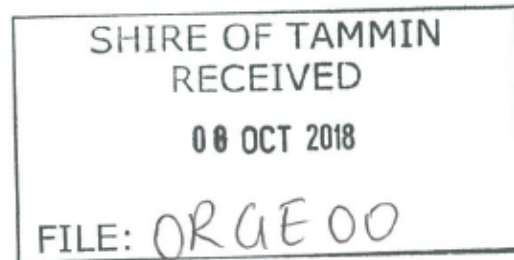

INTRODUCTION OF \$1,000 TOTAL FIRE BAN INFRINGEMENT

In November 2017, I wrote to you regarding the introduction of a process to investigate and coordinate Total Fire Ban (TFB) breaches under section 22B and 22C of the *Bush Fires Act 1954*.

During the 2017/18 bush fire season there were 26 TFB days declared and 62 breaches, with 25 of these the result of landscape fires.

Following discussions with a number of local governments, it was identified that the ability to infringe would provide a more streamlined approach, as well as serving as a more effective deterrent.

Local government can now issue a \$1,000 infringement notice as an option to prosecution for a TFB breach. I anticipate that the Minister will make an announcement in early October in relation to this matter.

I trust that this change will assist local government in managing fire risk in the community by providing an alternative option to deal with those individuals that breach TFBs.

I thank you for the valuable input and assistance in working collaboratively and seek your continued support to enforce TFBs and TFB exemptions this bushfire season.

Water Corporation wants your feedback on how we can use retired sections of the Mundaring to Kalgoorlie pipeline.

The nationally heritage-listed Goldfields Water Supply Scheme has been continuously upgraded over the years to ensure a safe and reliable water supply. It is estimated that around 8 to 10 kilometres of the 566 kilometre pipe will need replacing each year for the next 50 years.

Water Corporation would like community views on areas of significance along the pipeline for possible preservation in its original state and ideas for other uses when sections of pipe can be recycled and used to maintain and express its historical significance.

Submissions received will assist in the preparation of a referral under the *Environment Protection and Biodiversity Conservation Act 1999 (Cth)*.
