

Who is eligible for KidSport?

All Western Australian children aged 5 to 18 with a valid Health Care Card or Pensioner Concession Card are eligible for KidSport. Find your nearest club through Find a KidSport Club.

How does KidSport work?

You can apply for KidSport online or by using a hard copy application form.

KidSport applications are assessed by the local government in which the child resides or by the KidSport team at the department. If an application is approved, the KidSport team will email you a voucher code (unique to the child). The code needs to be provided to the club when registering so that the approved amount can be deducted from the registration or membership fees.

All voucher codes will expire in 90 days.

Recent changes to KidSport

- 1. As of 1 January 2018, the total funding available per child in a calendar year is \$150.
- 2. All clubs will have to meet the KidSport club eligibility criteria by 30 November 2018.
- 3. There is now a 90 day expiry on KidSport vouchers.

Enrolling to vote

For the Local Government Election on 19 October 2019

My circumstances are:	Do I have to apply to be on the roll?
You live in the district (or ward) and are on the State electoral roll.	No need to apply.
You live in the district (or ward) and are not on the State electoral roll.	Yes—Get a form from any post office or the WA Electoral Commission and get the form back to them by 5:00pm on 30th August 2019.
You are not an Australian Citizen but were on the local government electoral roll in 1996 and have owned or occupied rateable property in the district since then.	Yes—See how to apply be low.
Your property is rateable and is owned or occupied by more than two people or by a company.	Two people only who are not already on the local government roll for the district (or ward) must be selected by a majority of the owners or occupiers or the company. They must be on the State or Commonwealth roll to be eligible. If more than one property is involved the same two people must be nominated for all the properties.
You own property that is rateable in the district (or ward) and you are on the State or Commonwealth electoral roll but you live elsewhere.	Yes—See how to apply be low.
You have a right of occupancy of property in the district (or ward) that is rateable and you are on the State or Commonwealth electoral roll but live elsewhere	If you have a right of continuous occupation under a lease, tenancy agreement or other legal instrument for at least the next three months following the date you apply you should make an application—See how to apply below.

How to apply

You can get an "Enrolment Eligibility Claim" form from any local government office. To be able to vote for this election your application must reach the person named below by 4:00pm on the 30th August 2019. Those nominated by a company must attach the letter of nomination to the form.

Our cute killers: Cats are killing more than 1.5 billion native animals per year in Australia

Pet and feral cats together are killing over two billion reptiles, birds and mammals per year in Australia, and most of these animals are natives, according to a new book written by three of Australia's leading environmental scientists.

The book, <u>Cats in Australia: Companion and killer</u>, compiles key findings from hundreds of studies and management experience about cats across Australia.

With **feral** cats now a declared species in WA under the BAM Act we are looking forward to landholders having more options to control this damaging species on their land.

This new Declaration only relates to feral cats, and differentiates between feral, stray and domestic.

Wheatbelt NRM has been tackling the issue of feral cats for some years.

Over 180 feral cats were removed as part of our work with the community to protect populations of the Black flanked rock wallaby in the central Wheatbelt and one landholder last year caught a feral cat that weighed over 13kgs.

Works and Services Crew has been busy with road works in the month of July. The focus has been on clearing culverts to facilitate the drainage within the road reserve.
